Eligibility to play finals

All clubs are reminded to check their players are eligible to play in their selected sides. If you have a query, email gippslandbrpennant@gmail.com. Sides playing ineligible players will be disqualified.

BV Regional CoP

1.2 Sides of a club will be graded numerically (1,2,3,4 etc) in descending order of ability.

GBR COP

10.1. To be eligible to play finals, a player must comply with Clause 1 in the Conditions of Play (Eligibility of players) and must have played a minimum of 4 (four) games for the club in the Weekend Pennant and 3 (three) in Midweek Pennant competitions.

10.2. A side may not include any player who, during the current season has played more than four games in any combination of higher graded sides unless the player has also played in four or more games in the side concerned and/or a lower graded side.

10.3. The provisions relating to the interchange of players between sides in finals also apply to players involved in combined sides formed under Clause 2 BV Regional Pennant COP

10.4. A club who has insufficient eligible players for any finals of a region pennant competition may apply to the region pennant Committee for approval to play other players from the club. If this approval is granted, then such players may play in any position other than skip.
